### Minutes of a meeting held at the Village Hall, Winsley

**26. Matters Arising:**

It was reported by Cllr. Bennett that she had conducted a review of maintenance in the parish with the help of Jen Hiscock from Wiltshire Council.

**27.** A Police report was given by the Chair.

**28. Magnus Macdonald.** Magnus Macdonald was not at the meeting until after this item, he was delayed in travel from the Limpley Stoke meeting.

**29. Clerk's Report.** It was reported that there had been a lot of activity in the last month. The inquest into the death on the footpath at Turleigh was complete details had been published in local and national press. Details of the event at Harmony Wood had been circulated by email. The Chair has written to Wiltshire Council thanking them for running a replacement bus service during recent road works between Winsley and Bath.

It was also reported that the problems in Crossways Path with the suckers from a false acacia tree were resurfacing. Advice from WC was to continue to mow them, the Clerk expressed concern that this might just be disguising a tip of the iceberg situation and will take advice from the DoE.
